### 1 General information

This fact sheet serves as an overview of the supporting documents that must be submitted when opening, changing or closing a personal or operator holding account in the Swiss Emissions Trading Registry (referred to below as EHR).

#### 2 Legal foundations

The documents and information that must be submitted are based on <u>Article 58</u>, <u>Article 59</u> and <u>Article 49</u> (for auction agents and bid validators) of the Ordinance on the Reduction of  $CO_2$ Emissions ( $CO_2$  Ordinance<sup>1</sup>).

The FOEN may also require further information at any time if necessary for the secure operation of the EHR (Art. 62 para. 3  $CO_2$  Ordinance).

#### 3 Important points to note

- Users cannot be registered as an account representative (AR) and transaction validator (TV) or auction agent (AA) and bid validator (BV) at the same time (dual control principle). However, users can, for example, be an account representative as well as an AA or BV.
- No extract from the Swiss register of convictions need be submitted if it can be proven in the form of confirmation from a notary that there have been no convictions in connection with the offences listed in <u>Art. 59a para. 1 let. b</u> of the CO<sub>2</sub> Ordinance.
- Companies with headquarters in a country that does not maintain a commercial registry must supply alternative proof confirming their existence and the signatory powers of those individuals authorised to represent the company.
- The date of the documents that are to be submitted, as well as that of the official notarisation and secondary certification of authenticity may be no more than **three months** prior to the date the request is submitted.
- Persons who have lived in Switzerland for less than 5 years must also submit the extract from the criminal record of their home country (not older than 3 months).
- The following documents may be submitted as proof of residential address (this list is not exhaustive):
  - o Official confirmations of place of residence
  - o Bills from mobile telephone providers
  - o Statements of ancillary rental costs
  - Credit card statements
- If the documents are not issued in German, French, Italian or English, an authenticated translation into German, French, Italian or English must also be submitted.
- All supporting documents must be authenticated, including contact details of the certifying authority, except for documents that can be independently checked online at official offices (e.g. Swiss criminal records). If the documents are not authenticated in Switzerland, they must bear an additional apostille or relevant secondary certification of authenticity (list of competent authorities for issuing apostilles per country).

#### 4 Information required to open an account

The following pages list the information that the FOEN requires to open an EHR account, as well as certain tips on completing the form. We recommend that you collect all of the information you need before you begin, because it is not possible to temporarily save the data entered in the online form.

#### **ACCOUNT INFORMATION (\* required field)**

Account name\* You can choose any account name, but there may be only one account with that name in the EHR. Names may have a minimum of 10 and a maximum of 50 alphanumeric characters (letters, numbers and certain special characters such as hyphens or diagonal slashes), e.g. 'Personal account XYZ AG'. When you click on 'Next', the account name will be checked to make sure that it does not already exist. If it does already exist, you will be asked to choose a different name. The account name should not be confused with the account number, which is automatically assigned by the system.

#### 11 Fees

The fees for opening an account and for yearly account management are charged by the hour (CHF 140 per hour) in accordance with Art. 4, para. 1 b of the FOEN Ordinance on Fees (FeeO-FOEN<sup>16</sup>). As a rule, the following fees will be charged:

#### **Operator holding accounts**

The account that has been requested will be opened as soon as the corresponding fees have been paid.

As an invoice recipient in the Federal Administration, you have the option of registering to receive PDF invoices via email (<u>registration form</u>).

#### 12 Data protection

The storage of personal data complies with the provisions of the Federal Act on Data Protection (DPA<sup>17</sup>) and the Ordinance to the Federal Act on Data Protection (DPO<sup>18</sup>). Some of the data will also be available in the public area of the EHR.
